BUNNINGS RUGBY ASSIST APPLICATION T&Cs

1. This is a competition designed to provide community rugby clubs across New Zealand with the opportunity to access D.I.Y products and materials to improve or upgrade their rugby clubrooms or facilities (**Competition**).
2. Clubs could win a prize, valued at NZ\$30,000 which consists of Bunnings Warehouse store credit for the purchase of products and materials and reimbursement of labour costs (up to 25% of the prize value (up to \$7,500) to be used for improving or upgrading a club's facilities (**Prize**).
 - a) To facilitate use of Prize, the Competition's official building consultant support team must be engaged by winners at the cost of Bunnings Warehouse. Availability of hours will be allocated at Bunnings discretion.
3. Examples of facilities that winners may use the Prize on might include renovating, updating, installing, or improving:
 - a) Upgrading facilities to optimise club hosting – kitchens, lounges, outdoor areas
 - b) Updating facilities to be more inclusive and accessible i.e. female changing rooms, disability access
 - c) Upgrading facilities to be family-friendly, i.e. family corner, secure play areas
 - d) Upgrading facilities to be safe and secure, i.e. security, lighting.
4. Information on how to enter this Competition and the prizes form part of these Terms and Conditions.
5. Participation in this Competition via entry or acceptance of any prize is deemed as acceptance of these Terms and Conditions.
6. The Competition commences on Monday, 1 July 2024 at 09:00 NZST and closes Sunday, 4 August 2024 at 23:59 NZST (**Entry Period**).
7. Entry is open to grassroots community rugby clubs across New Zealand that have not already been a recipient of Bunnings Rugby Assist in 2021, 2022 and 2023. Entries are limited to one per club and must be submitted by a duly authorised representative of the Club (**Eligible Entrant**).
8. NZRC Employees (and their immediate families) of the New Zealand Rugby Union Incorporated (**NZR**) and Bunnings Ltd (**Bunnings**) (together the "**Promoters**") and the agencies associated with this promotion are ineligible to enter this competition on behalf of their local club. Immediate family means any of the following: spouse, ex-spouse child or stepchild (whether natural or by adoption), parent, stepparent.
9. This is a contest of skill, judged on criteria and merits determined by the Promoters as set out in these Terms and Conditions. All decisions are at the sole discretion of the Promoters and are final. Chance will not play a role in determining the competition winner. This Competition is free to enter.
10. Winners will be selected by a judging panel comprising senior Bunnings representatives and senior NZR representatives.
11. Winners of the Competition will be selected based on the following criteria:
 - a) the Eligible Entrant is a New Zealand Rugby Registered Club and

- b) the Eligible Entrant has in their Entry Form clearly demonstrated:
 - I. how the club serve their community.
 - II. how the club proposes to undertake the improvements of upgrades
 - III. how improving or upgrading their facilities will benefit their rugby community
12. There are ten (10) available Prizes (with a total combined prize pool value of NZ \$300,000) that will be awarded to the ten (10) winning clubs for the purpose of improving or upgrading their local club facilities. The ten (10) winning entries will each receive a Prize valued at NZ\$30,000 from Bunnings. The prize cannot be converted into cash, is non-transferable, and non-exchangeable.
 - a) Winners acknowledge and agree that the prize is only to be used for the purpose of improving or upgrading their club facilities as set out in the Entry Form (14a) or as otherwise agreed in writing by the Promoters. The labour cost percentage or value to be claimed will need to be identified by the winner and agreed with Bunnings at the time of winning, to ensure the allocation is saved from the remaining order of products and materials. Labour costs will only be reimbursed upon submission of a valid invoice evidencing the expense and will not be paid in advance.
13. Winners of the competition may be required to attend an official prize presentation and agree to any promotional personnel covering the Competition to photograph, interview and report on the Competition. In addition, the Winners will be required to participate in any print, TV or social media activity surrounding the competition, which may include progress updates on the use of the prize and resulting club improvements or upgrades. Eligible Entrants will be asked to provide their consent to participate in these activities as- part of the Competition entry process. If you do not provide your consent, you will not be eligible to enter the Competition.
14. To enter the Competition, an Eligible Entrant must, during the Entry Period:
 - a) Go to the Competition website: <https://www.provincial.rugby/bunnings-rugby-assist/> to access the Competition entry form (Entry Form);
 - b) Complete all required fields in the Entry Form, including, full name, position/title within the club, club details, location, phone and email address.
 - c) Provide the following information:
 - I. Introduce your club and tell us how it serves the local rugby community?
 - II. Select the upgrade package that will optimise your facilities to benefit your rugby community?
 - III. Share what the future impact would be of completing this project for your club? How would the upgrades benefit your rugby club community?
 - IV. Include a topline list of the upgrades you'd make along with the products, materials and trade labour help you might need as well as who will be on your team to help with the project? Include a timeline showing how you will complete the upgrades by June 30, 2025.
 - V. A video or photos demonstrating the need for the upgrades (maximum of 300MB)

- d) Tick the box where indicated to confirm you are a duly authorised representative of the club;
 - e) Tick the box where indicated to confirm that you have read and agree to these Terms and Conditions and that you agree to participate in media relations activities in the event that you are successful in winning a Prize; and
 - f) Once the Entry Form is fully completed, hit the submit button to submit the Entry Form. Entry Forms are deemed to be received at the time of receipt into the Promoters' competition database and not at the time of completion by the Eligible Entrant.
15. To be eligible to participate in the competition, entrants must be acting on behalf of a New Zealand Rugby Registered Club. This competition excludes semi-professional and professional sporting clubs such as Provincial Union and Super Rugby clubs.
16. The judging for this Competition will take place at Bunnings National Support Centre, Building 1, Level 3/660 Great South Road, Penrose, Auckland, 1051 in August 2024. The prize winners will be notified via email within 10 business days of the selection to organise the claiming of their Prize. The winners' names will be published on www.provincial.rugby and www.bunnings.co.nz in September 2024.
17. In the event that a winner is unable to be contacted, and all methods of communication are unsuccessful, or a winner does not respond to the Promoters' initial communications within 2 weeks, a further judgement for any unclaimed Prizes may take place at the same time and place as the original judgement. Winners, if any, will be notified in writing by email on the day of the selection and the winners' names will be published at www.provincial.rugby and www.bunnings.co.nz within 5 business days of the selection day. The Prize remains the property of the Promoters until claimed by the Prize winner.
18. The Promoters reserve the right, at any time, to refuse any Entry Form (and Eligible Entrants from entering the Competition) which: (a) it reasonably suspects have been submitted using false, incorrect, fraudulent, or misleading information; (b) are incomplete, illegible, or incorrect; (c) contain offensive or defamatory comments; (d) which breach any law or infringe any third party rights, including intellectual property rights; or (e) otherwise contravene these Terms and Conditions. If this promotion is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoters, the Promoters reserve the right, in their sole discretion to modify, suspend, terminate, or cancel the Competition, as appropriate. Failure by the Promoters to enforce any of its rights set out in these Terms and Conditions at any stage does not constitute a waiver of those rights.
19. Nothing in these Terms and Conditions limits, excludes, or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Consumer Guarantees Act 1993 (Non-Excludable Guarantees). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoters (including their respective officers, employees, and agents) exclude all liability (including negligence), for any personal injury or death; or any loss or damage (including loss of opportunity); whether direct, indirect, special, or consequential, arising in any way out of the Competition or accepting or using the Prize.

20. Winners are solely responsible for ensuring that they have obtained all applicable legal and regulatory approvals (including local Council and landowner consents/approvals (if applicable) prior to using the Prize to carry out any works associated with improving or upgrading the relevant club's facilities.
21. A winner's use of the Prize is entirely at their own risk. Before a Prize is awarded, a winner may be required to sign an agreement to release the Promoters from, and indemnifying the Promoters against, any liability arising from the winner's acceptance and use of the Prize and the winner's participation in the Competition.
22. The Promoters reserve the right, at any time, to request verification of any information relevant to an Eligible Entrants participation in the Competition and/or the Winner's use of the Prize.
23. Eligible Entrants consent to the Promoters using the Eligible Entrant's name, competition response, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this Competition (including any outcome) or the relationship between NZR and Bunnings. The Eligible Entrant can withdraw this consent at any time by notifying the Promoters in writing.
24. If the Promoters become aware that a winner of the Competition has not complied with these Terms and Conditions, that winner may be required, at the direction of the Promoters, to return, refund or otherwise make restitution of the Prize.
25. The Promoters accept no responsibility for any tax implications that may arise from the prize winnings. The Promoters recommend independent financial advice should be sought. Winners should be aware that a condition of accepting the prize will be the completion of various accounting and tax related documentation.

28. The Promoters are required to collect personal information from representatives of the Eligible Entrant for the purposes of conducting the Competition. If the information requested is not provided, the Eligible Entrant may not be able to participate in the Competition.
29. All information provided to enter this Competition including all personal information received from entrants will be held securely by NZR and used only in relation to the

administration of the Competition. This will include disclosure to Bunnings and any third party who has been engaged by the Promoters to manage the Competition (including Tradable Bits Media Inc who are providing the platform on which the Competition is run). 30. Each Eligible Entrant must ensure that any other person whose details have been provided by the Eligible Entrant to the Promoters for the purposes of the Eligible Entrant's participation in this Competition has given the Eligible Entrant their express consent for their details to be provided to the Promoters and any of its related companies and to be contacted by the Promoter(s) or any of its related companies in relation to this Competition.
31. The competition is governed exclusively by the laws of New Zealand.
